# HOW WE MEASURE SUCCESS

Tahoe Youth & Family Services are ongoing and target new community members who find themselves in difficult situations at different stages of their lives. Thus, success is measured at an individual level, client by client. Our Outcomes Assessment is a pre-post evaluation of our clients. Tahoe Youth & Family Services determines the client's status and improvement in nine life domains:

Risk of Harm
Recovery of Environment
Acceptance and Engagement
Overall Communication
Area of Self-worth & Self-identity
Work and or School performance
Functional Abilities
CO Morbidity
Connections with others



Our Outcomes Assessment also includes four questions that clients self-report on personal improvement made upon conclusion of our services.

The following is a snapshot of our youth clients who were discharged by the end of this fiscal year: 100% of youth improved by 100% in Risk of Harm, School, Self-worth & Self-identity and with Connection with others. These same youth improved their Level of Resiliency by 88% and by 75% in their overall Communication.

All adults as well as youth fill out a Client Satisfaction Questionnaire quarterly which is reviewed by the Executive Director and the Clinical Director. If challenges are found, then individual clinicians are spoken to so changes can be made to help improve our client's satisfaction with our services.

# FINANCIAL STATEMENT

#### THIS UPCOMING YEAR

Considering the many challenges that COVID brought to our community and nationally, Tahoe Youth & Family Services, fared fairly well. We moved all our in-person services to Telehealth within 24 hours of the NV Governor closing all businesses. Although our offices were closed for several weeks, all our staff continued to provide needed services virtually from their homes. This allowed us to continue to bill NV Medicaid. Telehealth has proven to be successful for delivering our services although due to virtual fatigue we are seeing a reduction in clients now. Due to many transitional aged youths losing their jobs in the hospitality and restaurant industry and at high risk of homelessness due to COVID, we expanded all housing assistance funding for Fiscal Year 2020 – 2021. Physical changes to our offices occurred in order to provide a safe environment for staff and clients as we looked to open in the future in a limited capacity. Tahoe Youth & Family Services received \$104,000 for the COVID PPP.

Tahoe Youth & Family Services had to cancel two fundraisers due to the pandemic. However, Board members and staff were creative and thought outside the box and created a virtual Trifecta to help make up for the lost revenues that occurred with the cancellation of two fundraisers. Many race participants donated on-line, and our Event Sponsors were very generous which helped kick start our fundraising efforts during this challenging year. Although there were some hiccups in some areas, we continue to move forward. We updated our Annual Fund Development Plan with the hopes of increasing unrestricted dollars such as:

A Holiday Appeal

A Trifecta of Recovery Events, (Miles for Recovery - September 2020, Minutes for Recovery - March 2021 & Movement in Recovery – June 2021.

An outdoor Private Dinner party is scheduled for the first quarter of Fiscal Year 2021-2022

We continued to add additional Board members from each of the communities we serve, and board training continued at each board meeting virtually. We also created an Advisory Council with seven members representing Douglas County and South Lake Tahoe

#### **SUSTAINABILITY**

We continue to develop diversified revenue streams to ensure continuous income. We also continue to be a fee for service organization and are a NV Medicaid and Medi-Cal provider. We have created mental health and substance abuse counseling packages providing our clients opportunities to receive a discount on our services if paid upfront.

We continue to strive to keep counseling costs below the average rates so more families can access these vital services. During this upcoming Fiscal Year, we will explore the possibility of increasing these costs due to the increased cost to maintain qualified licensed professionals on our staff.

It is hoped that as more people get vaccinated Tahoe Youth & Family Services will be able to continue our last year's plan of having a major in-person fundraiser along with continuing our Friend Raising parties to increase our outreach to community members and create more friends. We will continue to increase the number of government and private grants.

Tahoe Youth & Family Services has created an Emergency Succession Plan for the Chief Financial Officer and the Executive Director. We have created a Gift Acceptance Policy as well as an Operating Reserve Policy which we hope to begin contributing to this next fiscal year. We will complete our Agency Succession

plan which looks at all aspects of Tahoe Youth & Family Services including all policies and procedures and create an Investment policy. Finally, a Planned Giving Brochure will be created along with other documents to distribute throughout the community to attorneys and financial planners. This will contribute to our long-term sustainability plan for the future of Tahoe Youth & Family Services.

Sustainability is not just about raising funds. It is also about being missiondriven, focusing on intermediate and long-term goals, maintaining a stable and skilled staff, improving activities as opposed to re-inventing them. We are working on demonstrating program effectiveness and high credibility with our clients and community as well as building long term partnerships and collaborations.

During fiscal year 2019 – 2020, Tahoe Youth and Family Services audit had no findings. This year ended with a positive balance of \$29,572.21. Although we saw improvement in some areas, we still had financial challenges including:


> Insufficient unrestricted/ fundraising dollars raised. Increased costs associated with being able to recruit qualified counselors. Decrease in counseling referrals



ents because of fear of the pandemic and on-line fatigue.
