### **OUR PROGRAMS**

#### DRUG STORE PROJECT

The Drug Store Project, housed by TYFS, is a comprehensive middle school drug prevention program designed to educate youth about the dangers of substance use and abuse. Here in South Lake Tahoe, The Drug Store Project is in its 17th year and continues to be the single largest collaborative prevention activity that is conducted in our area. Early on, the team of like-minded individuals in our community collaborated with the idea that each of us could bring our talents and know-how together for a common good: providing our youth with an impressive opportunity to learn that they themselves will be the individuals making the final decisions when it comes to drug experimentation and use. The Drug Store Project is a series of vignettes which students experience first-hand. This program is a true community effort we continue to feel proud to help deliver to our community's youth.



### **MENTORING**

Tahoe Youth and Families Mentoring Program used an evidence-based program to create an enduring, positive impact on the lives of underserved, disadvantaged and high-risk local youth and their families. Our mentors helped build healthy youth development by introducing mentees to new activities and diverse alternatives free from high-risk, unhealthy behaviors.

### **OUR PROGRAMS**



### **COUNSELING PROGRAMS**

Tahoe Youth & Family Services offers counseling in both Nevada and California (Douglas County and South Lake Tahoe) for both children and adults. Licensed therapists provide counseling, solution-focused therapy, trauma therapy, play therapy and family unification services. Certified substance abuse counselors provide strength-based services for clients struggling with the disease of addiction. We strive to inspire clients to discover their own path to recovery in both individual and group counseling sessions. Our staff is trained in evidenced-based strategies to provide prevention, intervention and outpatient services to adults and youth. We served 165 adults and 69 youth in our Mental Health and Substance Abuse programs.

### **OUR PROGRAMS**

#### SUPPORT SERVICES FOR RUNAWAY & HOMELESS YOUTH

Tahoe Youth & Family Services integrates positive youth development and preventative services strategies into our culture of care, embracing harm-reduction and trauma-informed approaches in order to assist runaway, homeless, and street youth (RHSY) in achieving safe, stable living arrangements and self-sufficiency. TYFS implements positive alternatives for RHSY, improving their immediate and ongoing safety, well-being, self-sufficiency and permanent connections. TYFS supportive services focuses around a Comprehensive Youth Services Model and provides a full continuum of services including: a 24-hour crisis line; drop-in center services; crisis intervention services; assessment; coordinated case management; individual, group and family counseling; preventative services; emergency temporary shelter via Host Homes and safe alternative placements; and after-care services.

#### **DROP-IN CENTERS**

A place where youth can come get recharged, get resources and get respect. The Drop-In Center provides runaway, homeless and high-risk youth with basic needs and supportive services to help their well-being, promote self-sufficiency and provide permanent connections with caring adults.

#### PREVENTATIVE SERVICES PROGRAM

Our Preventative Services Program incorporates a positive youth development framework to motivate young people to use their time in a positive way, maintain safe and healthy behaviors, and redirects others to engage in healthier and more positive actions. The focus is on promoting the social, emotional, spiritual, and mental well-being to prevent homelessness. Youth involved in this program are overwhelmingly from homes without a father figure, lack strong parental guidance due to their caregiver's substance use, or are at risk of engaging in problem behaviors such as delinquency, drug use, teen pregnancy, or truancy due to the lack of appropriate role models. One-on-one community-based mentoring is an evidence-based substance abuse prevention approach that has shown success in steering youth away from these problem behaviors.

## EXCITING PROGRAM UPDATES FOR OUR CURRENT YEAR

#### **Douglas County**

- Our teen mental health group has 15 participants attending. Teens enjoy the group and love that we feed them.
- Our children's group is growing with 6-8 participating weekly. It is a lively group of 7-12 year olds who have so much energy.
- We are starting an LGBTQ+ group for teens.
- We are providing services in a recently opened sober living facility.
- Our three adult substance abuse groups are well attended with as many as 12-15 attending each one weekly.
- One of our donors generously provided funding for us to purchase CAFAS, a children's assessment tool.

#### **South Lake Tahoe**

- Our Basic Center Program for South Lake Tahoe was funded for another three years.
- Our Mental Health and Substance Abuse program at the El Dorado County Treatment Center is extremely busy providing individual and group counseling.
- Our Heap program funding is providing a Transitional Living program to transitional age youth, ages 18-24. This program housing first approach offers low barrier, voluntary services, case management and is available up to 18 months per youth. There is a huge need for this program and we are very busy.
- We received a Mental Health grant from the Katz Amsterdam Foundation to increase our services.
- We will be providing a Matrix group, an evidenced-based program, in South Lake Tahoe High School for teens.

#### Additional updates:

We are certified by the Nevada Nursing Board to facilitate a Nurses Support Group.

We are now certified to supervise social work interns in Nevada and California.

We are creating a volunteer program to increase our outreach.

### THIS UPCOMING YEAR

This year continues to see positive changes with unrestricted dollars being raised. This last year, we updated our Fund Development Plan which provides a variety of fundraising goals such as:

- A Holiday appeal
- 3rd annual 5K Run, Jog, Walk event for Carson Valley Days—June 13, 2020
- Speakeasy Fundraiser—May 2020 at Genoa Lakes, Minden NV
- Friend Raising parties
- Ongoing donor cultivation

As we all know, change is challenging, but change can also be exciting. With change comes opportunity and both our staff and Board are viewing this as a time to look forward and not backward.

We continue to add additional Board members from each of the communities we serve, and board training happens at each meeting. Both the Board and staff are using their strengths to create momentum and move us forward in a positive way. The Board bylaws were updated to better reflect the need to have board members who are energized in helping us stay focused on our mission.

### **SUSTAINABILITY**

We are building our organization by continually looking to develop diversified revenue streams to ensure continuous income. Currently, we are a fee for service organization. We are a Medicaid and Medi-Cal provider.

Beginning July 1,2019 we increased our counseling fees to help improve the financial gap between the actual cost of the services. We continue to strive to keep counseling costs below the average rates so more families can access these vital services. Focusing on utilizing more volunteers to provide outreach will help increase our revenues through grants and fundraising dollars. One major fundraiser is planned for 2020 along with Friend Raising parties to spread awareness and garner more volunteers and donations. We will continue to increase the number of government and private grants.

Sustainability is not just about raising funds. It is also about being mission-driven, focusing on intermediate and long-term goals, maintaining a stable and skilled staff, improving activities as opposed to re-inventing them. We are working on demonstrating program effectiveness and high credibility with our clients and community as well as building long term partnerships and collaborations.

During fiscal year 2018-19, Tahoe Youth and Family Services audit had no findings. The year ended with a positive balance of \$37,892.62 Although TYF saw improvement in some areas, we still had financial challenges including:

- Insufficient unrestricted/fundraising dollars raised
- ◆ Decrease in counseling referrals in South Lake Tahoe
- Decrease in government grant dollars
- Additional funder reporting requirements


Due to loss of federal funding for our Nevada Basic Center grant we closed the Douglas County Drop-In Center and negotiated our lease in order to vacate the property. This loss also has created staff capacity challenges and has made things more difficult to increase additional grant and fundraising dollars and meeting the extra funder reporting requirements.


We also renegotiated our South Lake Tahoe lease and were able to give up some of the space we no longer needed to reduce monthly costs.

We ended our two contracts with Alpine County this year. The funding received did not pay for the entire costs of the programs and the Executive Director and Board decided to concentrate on providing excellent services in two locations rather than three.

The **good news** is we are still open and providing services. Our Nevada office has increased its revenue substantially through our Mental Health Counseling and Substance Abuse Counseling programs. One donor made a sizable donation which made a huge difference in Tahoe Youth and Family Services excess fiscal year balance.
